## Contractual Agreement

This Contract is between Open Connections (“OC”) and the parent(s) or legal guardian(s) (referred to as “Parent/Guardian”, which term includes the singular or plural, as applicable) of the above-referenced youth(s) (hereinafter “Youth”). This enrollment contract runs from the date of signing through June 30, 2025. Parent/Guardian understands that registration is a non-refundable commitment and that by signing below, Parent/Guardian agrees to honor this agreement.

Parent/Guardian further understands that the overhead expenses of OC do not diminish with the departure of a Youth during the course of the camp and agrees that it is impossible for OC to determine at the time of Parent/Guardian’s execution of this Contract the loss to OC that would occur due to the later cancellation/withdrawal of a Youth who has enrolled. Therefore, once this Contract has been submitted to OC with the full payment, Parent/Guardian becomes liable for the entire camp fee even if the Youth is withdrawn, absent, or is involuntarily separated from OC. If Youth is withdrawn, absent, or involuntarily separated, for any reason, including without limitation: change of residence, health, withdrawal, or expulsion, after this contract is signed, there will be no refund or reduction of fees.

**OC GUIDELINES:** A positive and constructive relationship between OC, youth and family members is essential to OC’s educational purpose and responsibilities. We expect that all members of our community – youth, staff, families, visitors – will behave in a positive, supportive, pro-social, and respectful way both on campus and off campus. Parent/Guardian acknowledges that Parent/Guardian and Youth must abide by stated rules and guidelines.

**TERMINATION OF YOUTH’S ATTENDANCE:** OC has the right to suspend or terminate the attendance of Youth for reasons set forth in this Contract, for reasons that OC administration considers detrimental to the OC community, to the Youth, or to other Youth of OC, or for the Parent/Guardian’s failure to pay all or any part of the Parent/Guardian’s financial obligations for Youth’s attendance.

**YOUTH PHOTOS, VOICE, AND IMAGES:** Parent/Guardian agrees to allow Youth’s name, photograph, voice, image, and information to be used by OC, and those acting with OC’s permission, for use in OC’s publications, promotional materials, website, and social media accounts, without compensation and without prior notice. Parent/Guardian agrees to allow Youth to be interviewed by the media on campus or at OC-related events. Parent/Guardian also consents to the recording and distribution or live streaming of Youth’s voice, image and video in instruction or presentations as may be deemed appropriate in OC’s discretion. Parent/Guardian releases and holds OC harmless from any liability stemming from the use of the Youth’s name, photograph, voice, video, image, or information. If the Parent/Guardian wishes to revoke this permission, written notification must be submitted to OC Director so that it is received no later than June 1, 2025, or upon registration if enrolling after June 1, 2025.

**RISK OF INJURY:** Parent/Guardian understands that camp activities could include activities including hikes in the woods wherein there could be mosquitos, bees, ticks, poison ivy, and slippery and jagged surfaces among other dangers and risks. Parent/Guardian also understands that outdoor activities may occur in the hot sun and in the rain and agrees to see that Youth is appropriately attired and prepared for camp activities. Parent/Guardian understands that the risks associated with camp activities could result in injury and/or death to Youth. Parent/Guardian hereby assumes these risks and, knowing them, hereby give Youth permission to participate. Parent/Guardian understands that OC is not liable for any injuries or other occurrences due to camp activities or related risks, and/or the actions or omissions of OC camp staff, volunteers, employees, board of directors, or any other entities being released.

**CONSENT TO ON SITE MEDICAL CARE:** In the event of illness, injury, and/or accident, Parent/Guardian authorizes the camp staff or any OC employee to act on Parent/Guardian behalf. They may approve any and all non-emergency or emergency treatment and are authorized to sign any and all medical release or required form(s) on Parent/Guardian behalf. In the event of an emergency, Parent/Guardian will be notified of the situation as soon as practicable. Parent/Guardian agrees to pay any necessary expenses not covered by OC’s accident policy incurred in the medical treatment of Youth, including, but not limited to all transportation costs to and from a medical facility. Parent hereby releases and holds OC harmless from any liability which might arise from the provision of such medical care.

**COVID RISK ACKNOWLEDGEMENT:** OC cannot promise that even with the steps we are taking, that your Youth will not be exposed to COVID-19. By sending your Youth to OC, you acknowledge the contagious nature of COVID-19 and knowingly and voluntarily assume the risk that you and your Youth may be exposed to or infected by COVID-19 by coming to our campus and participating in OC activities, such as but not limited to the sharing of supplies, belongings, and equipment, and that such exposure or infection may result in personal injury, illness, permanent disability, or death. You further acknowledge and understand the risk of becoming exposed to infected by COVID-19 may result from

or be caused by the actions, omissions, or negligence of yourself or others, including other OC families, OC employees, or other third parties.

**PROMOTIONAL MATERIALS/STATEMENTS:** OC continually strives to ensure the accuracy of all written and digital materials, including, but not limited to, brochures, handbooks, and advertising. Please understand that even if the information was accurate at the time that you enrolled Youth, the information may change prior to commencement of camp or during attendance at OC's camp. Please also note that only an OC Co- Director (or their designee) has the authority to make commitments regarding the nature of the camp, specific arrangements for Youth, or other changes from OC's regular camp programming.

**FORCE MAJEURE:** Should events beyond the control of OC, including, but not limited to, fire, extreme weather, governmental action, risk of infectious disease, disruption of necessary utilities, or any other event beyond OC's control, occur, OC has the discretion to close OC's camp and/or modify its schedules, length of day, length of camp. Parent/Guardian may be required to sign a waiver of liability in order for Youth to participate in on-campus programming depending on the status of any force majeure event. Parent/Guardian's financial obligations under this Contract remain in full force and effect and OC shall not be liable for any such failure or delay in its performance. Should OC camp close, OC's duties and obligations under this Contract shall be suspended immediately without notice until OC, in its sole and reasonable discretion, may safely reopen. If OC camp cannot reopen due to a force majeure event under this Paragraph, OC is under no obligation to refund any portion of program fees paid.

**ENTIRE AGREEMENT:** This Contract sets forth the entire understanding of the parties hereto with respect to the subject matter hereof and merges and supersedes all prior and contemporaneous oral understandings between the parties. There have been no representations or warranties made by any party other than the representations and warranties contained herein. There will be no modifications of this agreement unless they are in writing and signed by an OC Co-Director (or their designee).

Parent/Guardian hereby gives permission for Youth to participate in the Open Connections Summer Camp Program. Parent/Guardian acknowledges that this Contract will be used by Open Connections and that it will govern the actions and responsibilities at said activity.

In consideration of this application and permitting Youth to participate in this activity, Parent/Guardian hereby agrees to:

**WAIVE, RELEASE, AND DISCHARGE** from any and all liability, including but not limited to, liability arising from the negligence or fault of the OC, its board of directors, employees, camp staff, volunteers, entities or other persons released, for Youth's death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to them including their traveling to and from this activity;

**INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE** OC, its board of directors, employees, volunteers, or other entities or persons released from any and all liabilities or claims made as a result of participation in this activity, whether caused by the negligence of release or otherwise.

This Contract shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. OC, its board of directors, and all its employees, acting officially or otherwise are hereby released from any and all claims, demands, actions, or causes of action on account of any injury to Youth that may occur. This release binds Parent/Guardian heirs, executors, administrators, and/or assigns.
